Community Forum: Poverty Awareness Month

Beth Atherton, Dan Pruett, Lee Manford, and Ellen Balthazar

Panelists Beth Atherton, Executive Director, Caritas of Austin; Dan Pruett, Executive Director Meals on Wheels and More; Lee Manford, Executive Director, AIDS Services of Austin; and Ellen Balthazar, Executive Director Any Baby Can, outlined the goal of the Basic Needs Coalition (BNC) which is to build systems that collectively address the Basic Needs of Food, Clothing and Shelter. The Basic Needs Coalition, in collaboration with CAN, is sponsoring Poverty Awareness month. The panelists distributed the Poverty Fact Sheet and outlined the month's activities which include: weekly e-mails, pulpit messages, and a Poverty Awareness tour to be held on January 25. The goal is to focus the community's attention on the poor and to provide opportunities for people to engage in solutions. Panelists outlined the innovative Best Single Source program which the BNC has created to keep people in housing and more efficiently address needs. Panelists stated that this coalition is different in that the members communicate constantly, have built trust, share resources, and have become an agent for change. Panelists requested that Community Council members: 1) Collectively change the public policy discussion to address those affected by poverty, 2) Contribute to Austin Energy's CAP fund and 3) visit 2-1-1 or www.basicneedsctx.org to find opportunities to volunteer or donate. Discussion: Members discussed a variety of ways in which local initiatives could address poverty including supporting the proposal that affordable housing be included in the proposed City bonds. Members praised the panelists for the Coalition's work and encouraged them to create tools that the community can use to address the issues. In response to a question about how conceivable it is that things can change for the better, panelists reported that by creating a cohesive message and working together to address system change, they are seeing increased resources and benefits for clients. Panelists encouraged members to: 1) commit to talk to 5 people about poverty, 2) Include poverty as a topic for dialogue in future Community Council meetings, and 3) determine how to address poverty within their own organizations. Members discussed additional

topics that relate to poverty that could be explored at future meetings:

- Impact of Living wage
- The continuum of affordable housing
- Impact of investing in prevention

One member stated that there is now a suggestion to use the language of capacity development vs prevention. The Program Committee will review these recommendations when creating the plan for the year.

2006 CAN Workplan & Community Council Role

Fred Butlei

Fred reviewed the proposed 2006 workplan elements for CAN which include: 1) Educate the community about the return on investment of social services, 2) Strengthen and Support the CAN Issue Area Groups, 3) Use technology effectively, 4) Understand our Community, and 5) Katrina Debrief and Impact. Al reviewed the potential role that the Community Council could take in these elements. **Discussion:** Members expressed a desire to look at the following issues: 1) the balance between affordable housing and a living wage, 2) Poverty and its off-shoots, including the capacity development aspects, 3) mental health and its impact on the community, including the jail system, 4) The impact of the lack of health insurance on the community, 5) cross-cutting issues identified by Issue Area Groups and 6) African American Quality of Life Survey. In addition, it was suggested that it might be helpful to have some of the Institutions and CAN Partners come and provide an update on how they impact social services. It was stated that as part of each program, members should be asked how they are addressing the growing diversity in the community.
