### I. CALL TO ORDER:

Dan Pruett called the meeting to order at 9:10 a.m.

## II. APPROVED THE APRIL 28, 2005 MINUTES:

The minutes of April 28, 2005 were reviewed. Page 1 – *Darla Gay* was misspelled as Darla *Guy*. *Iris Graebner* was not at the meeting. *ARC of the Capital Area* should be replaced with *Arc of the Capital Area*. A **Motion** to accept the Minutes as amended was made by Sherri Fleming and **Seconded** by Mary Teeters. **Motion Approved.** 

#### III. PRESENTATION:

Dan Pruett of Meals on Wheels and More introduced Chris Maher, President/CEO of Fosforus, Inc. Mr. Maher introduced David McKnight and Kevin Burris, two staff members from Fosforus. He thanked the members of Basic Needs Coalition of Central Texas for all the work they have done. Then asked, "What is a GoodCity" and noted that the "Welcome to the GoodCity.org" website is designed to help ask the question: "What is needed to create a GoodCity." He announced that Fosforus will commit a contribution of \$12,000 over the next year to Basic Needs Coalition of Central Texas.

## **IV.** Committee Reports:

#### PLANNING - SHERRI FLEMING

- ➤ Sherri Fleming and Joy Stollings presented the look of the color logo.
- > Sherri announced that the planning committee thought it would be a good idea to combine the Planning Committee with the Advocacy Committee. A **Motion** to combine the committees was made by Susan Eason and **Seconded** by Ellen Balthazar. **Motion Approved.**
- > The Planning Committee is working with the staff of Health and Human Services to develop a training curriculum for the food stamp program.
- > Joy Stollings announced that at the next monthly meeting they would be presenting a draft copy of the fact sheet on utilities.

#### MEMERSHIP – GEORGE BROWN

➤ George Brown announced that the committee would be distributing a draft copy of the recommended changes to the Bylaws at the August meeting.

### BEST SINGLE SOURCE - LEE MANFORD AND GEORGE BROWN.

- ➤ The Committee is continuing to monitor the implementation of Best Single Source and continues to look for additional funding.
- ➤ George Brown announced that Austin Energy will have a Brochure going to the printer in July and it will be ready for mailing in August.
- Austin Energy is preparing posters announcing the enrollment program with the assistance of its marketing folks. Target time for completion is 2-3 weeks prior to the release of the brochures so that clients will have a heads up.

#### RESOURCE DEVELOPMENT – JULIA SPANN.

- ➤ Kay Bailey Hutchinson has agreed to give us a \$248,000 grant.
- ➤ Karen Affeld from Caritas is writing a grant to the Department of Health and Human Services, Community Food and Nutrition Program on behalf of Basic Needs Coalition of Central Texas for a "Food and Nutrition" \$50,000 grant. The purpose of the grant is to coordinate private and public food assistance resources to better serve low-income people.
- ➤ Need more members to be involved with the Resource Development Committee and to help with the grant writing.

### FOOD - MARGIE FERNANDEZ-PREW & ADELITA WINCHESTER.

- > The Food Committee has formed a sub-committee for the downtown area.
- ➤ They said there was one request for survey results and asked if they had the Board's. permission to release the information. Dan Pruett suggested that this be brought up to the Executive Committee as a topic of discussion.
- ➤ Highlights of the survey result (1<sup>st</sup> draft) have been completed.

### ADVOCACY - SUSAN EASON.

Susan Eason announced that the meeting to discuss the presentation to the Editorial Board meeting will be next week. The topic for discussion will be: "The Needs of Austin; what kind of problems do we face, what are the needs, and what kind of actions will be taken."
