# I. CALL TO ORDER AND INTRODUCTIONS:

Dan Pruett called the meeting to order at 9:10 a.m.

## II. APPROVED THE FEBRUARY 24, 2005 MINUTES:

The minutes of February 24, 2005, were reviewed and amended by deletion of the following sentence from the Resource Development Committee Report: The deleted sentence is: "An application has been submitted on behalf of the Best Single Source project for TDHCA, ESGP Homeless Prevention grant tech support." A Motion to accept them as amended was made by Julia Spann and Seconded by Sherri Fleming. Motion Approved.

#### III. CHAIR'S REPORT:

Dan asked Christy Moffett to give the Board a Comprehensive Energy Assistance Program (CEAP) update. CEAP furthers the Texas Department of Housing and Community Affairs' goal to provide affordable housing throughout the state by providing energy assistance to Texans. Energy costs significantly influence the affordability of housing for everyone, often impacting the basic subsistence requirements of a household. The Department's Energy Assistance programs are designed to encourage household energy self-sufficiency by providing energy related education and encouraging conservation. TDHCA's Energy Assistance programs are administered through the Department's Community Affairs Division.

#### PRESENTATION:

Pat Alaniz and Sonja Prevo with Austin Energy made a presentation. Ms. Prevo said that Austin Energy is seeking to serve the Central Texas community better and is exploring ways to reach people who are not currently served. The program, called Beyond Plus +1 (Customer Assistance Program), assists customers who are behind on their utility bills due to unexpected emergencies. These applicants must be City of Austin Utility customers, and must meet the criteria of the agencies.

### IV. COMMITTEE REPORTS:

#### PLANNING - SHERRI FLEMING

- ➤ Sherri announced that Joy Stollings with Meals on Wheels and More is rejoining the Planning Committee as Co-Chair.
- ➤ There will be a Basic Needs Press Conference on April 11, 2005 at 10:00 a.m. at Caritas to discuss the FAQ and to talk about the success of the Best Single Source Pilot project.
- ➤ The Planning Committee has a full menu and requests assistance from partner agencies by having some partner agency staff work with the committee. It meets on the second Wednesday of each month at 1:30 p.m. at Palm Square Building.

## BEST SINGLE SOURCE - LEE MANFORD AND GEORGE BROWN.

- ➤ One of the things we will look at in the future is identifying proposed roles for the Committee and the Work Group.

- Another thing we need to look at is: Best Single Source is a really good program for eligible clients but it is not a program that will work for everyone. Therefore, there is still a tremendous need for one-time assistance.

- ➤ The Committee met to identify local food services providers and ultimately will discuss challenges, duplication of effort, and possible collaboration.
- ➤ We started with a survey of food service providers. We completed 19 surveys to date and will present the preliminary findings to the Coalition.
- Meg and Jason will complete a map of all downtown providers and the Committee will finish the survey and submit a final report and its recommendations next month.
- ➤ The Food Committee will meet on the third Wednesday of each month from 10:30 12:00 at a site TBD.

- ➤ Lee Manford announced that last month AIDS Services of Austin made a presentation to the City with Vince Cobales and David Lurie and wanted to acknowledge and thank them.

- ➤ Christy Moffett announced that Travis County HHS has approved the Best Single Source Pilot. Its plan is to begin April 1.

- Marco Galvan said 2-1-1 took it only for "the first yard and George Brown and the Best Single Source team took it the rest of the way." He said they had a very productive meeting with the case managers and were working on the most effective way to make direct referrals.
