III. COMMITTEE REPORTS:

PLANNING/ADVOCACY- ELLEN BALTHAZAR

- Ellen announced that all projects of the advocacy committee, the final version of the Food Fact Sheet and website reconfiguration, will be ready for next month's meeting.
- Ellen asked that the members of the BNC create a link to the BNC website on our own agency's website.

MEMERSHIP -

BEST SINGLE SOURCE - GEORGE BROWN

- Best Single Source has 450 households to date that are being assisted and the target number is 650 households. BSS has provided \$345,000 to clients.
- The Long Term Recovery program has had 336 households under full case management, with an additional 300 families that are receiving some level of case management. \$53,000 has been used for assistance.
- A luncheon for the case managers is being discussed and planned for the fall to thank them for their hard work.

FOOD COMMITTEE - BEA DE LA ROSA

The Food Committee has completed the food survey. It only needs to be reviewed and edited. It will be presented at the October BNC meeting.

UTILITY TASK FORCE – BETH ATHERTON

Utility Task Force Committee announced that there would be training for case managers on August 24th and August 29th. If any agency would like to be involved in the next training session, please let the Utility Task Force Committee know.

AGENCY ANNOUNCEMENTS:

- ➤ Sam Wollard announced that on Saturday, August 26th, there would be a Texas Benefits fair with 60-80 state workers to help the community apply for benefits. Also, on September 9th, Houston Tillison will have a Hurricane Survivor fair to mark the 1 yr anniversary of Hurricanes Katrina/Rita.
- Dan Pruett announced that Thad Rosenfeld with KEYE News was interested in attending a BNC meeting and possibly a story about the Basic Needs Coalition. Dan will extend an invitation to come to the September meeting. Also, Dan mentioned a Cash and Counseling program that has started in St. Louis. Money is directly given to the clients for food and necessities. Dan will follow up with more information on such a program and whether it will come to Texas.
- ➤ Rick Rivera announced that the Homeless Task Force would be having an Annual Stand Down on Saturday, November 4th; services will be available for veterans. Services include health, hygiene and vetinary services for pets. It will be from 9 am to 2 pm at the Pan AM Recreation Center. Also, Friday, November 17th,information on homelessness will be provided at St. David's from 11 am to 1 pm. A goal of the Homeless Task Force is to educate the community on this issue.
- ➤ Tracey Whitley announced the 40th anniversary of Legal Aid. They are having their open house for their new building on October 3rd from 6 pm to 8 pm.
- ➤ Jana Bisbey announced that Saturday, August 26th, Top Draw Food Store will have a fundraiser to celebrate the thirteen anniversary; live music, food and drinks. Also, there will be a softball tournament held in October to raise money for Project Transitions.
